1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. A. Liquid Nitrogen (LN₂)

Detailed Specification:

1. Institute Background:

ICMR-NIRRH is a Research Institute functioning under the Ministry of Health & Family Welfare, Government of India. Its major focus is on research in various biomedical fields.

2. Purpose:

The requirement of Liquid Nitrogen (LN₂) is for research and allied laboratory activities.

3. Liquid Nitrogen Grade :

Liquid Nitrogen should be of Grade 5 or Higher. i.e., purity of 99.999% or Higher

4. Cylinder Capacity:

The institute uses LN₂ cryocylinders (TA55 or Higher) of different capacities such as 30L, 60L, 90L, 120L, etc. For the purpose of quotation and billing, 30L shall be treated as one unit. Billing will be done proportion

ally based on the actual supply in 30L units.

Additional Terms & Conditions (ATC) - Liquid Nitrogen:

1. Inclusive Pricing:

Quoted prices must include taxes, transportation, unloading, handling, and refilling or any other charges required for ensuring

2. Delivery Schedule:

Material must be supplied within 48 hours of intimation through telephone or email.

3. Location Requirement:

The service provider must be based in Mumbai or have an operational office and plant within Mumbai district.

4. Accessories Supply:

Regulator, cap, or related accessories should be supplied at actual cost, which should be included in the bid price.

Their cost should be quoted in a separate PDF document on company letterhead.

5. Penalty Clause:

Applicable as per GeM General Terms & Conditions for the relevant category.

6. Billing Criteria:

Billing should be done based on actual number of 30L units supplied.

7. Standard Unit for Calculation:

Regardless of cylinder size, 30L will be treated as one unit for billing purposes.

Additional Terms & Conditions (ATC) - CO₂ and Mixed Gases:

a. Delivery Schedule:

Gases must be supplied within 48 hours of request via telephone or email.

b. Location Requirement:

The vendor must be based in Mumbai or should have a functional office and operating plant in Mumbai district.

c. Accessories:

The regulator/cap must be supplied at actual cost, and the cost must be specified in a separate PDF on company letterhead.

The cost of accessories and any necessary testing charges should be included in the bid value.

d. Penalty Clause:

As applicable under GeM General Terms & Conditions for medical gases.

e. Premix/Mixed Gases:

These gases are required occasionally. Vendors must quote rates for these items separately in a PDF document on letterhead

2. Experience Certificate for the supply of the same to any Govt/ PSU/ any renowned private organisation along with Supply/ Purchase Order.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. 5. **Service & Support**
